COVID-19 Small Business Recovery Grant Program

\$800 million

Who's Eligible?

Small businesses, micro-businesses, for-profit independent cultural organizations

- Operation after March 1, 2019
- Show loss of gross receipts as a result of COVID-19
- Have 2019 or 2020 Gross Receipts of between \$25,000 -\$2.5M per annum
- Demonstrate positive net profit on 2019 Business Return (\$1 or greater)
- Demonstrate at least 25% loss in Annual Gross Receipts in a year-to-year gross receipt comparison as of 12/31/20, to the same period in 2019.
- Demonstrate that the total business expenses on the 2020 business income return are greater than the grant amounts.
- Not have qualified for business grant assistance programs under the federal American Rescue Plan Act of 2021 or any other available federal COVID-19 business assistance grant programs, including loans forgiven under the federal Paycheck Protection Program, or are <u>unable to obtain</u> <u>sufficient business assistance from such federal</u> <u>programs.</u>

Eligible applicants may have received the following:

- PPP loans totaling \$250,000 or less
- COVID-19 EIDL Advance grant of \$10,000 or less
- COVID-19 EIDL Supplemental Targeted Advance Grant of \$5,000 or less
- SBA Shuttered Venue Operator Grant
 - SBA Restaurant Recovery Fund recipients are ineligible.

How Much Can My Business Receive?

Grant awards will be calculated based on a business's annual gross receipts for 2019

- \$25,000 \$49,999.99: Award is \$5,000 / business
- \$50,000 \$99,999.99: Award is \$10,000 / business
- \$100,000 \$2,500,000: Award is 10% of gross receipts or a maximum of \$50,000*

How Much Funding Is Still Available?

More than \$750 million remains available for eligible businesses

* Preference given to "socially and economically disadvantaged" business owners but does not exclude any as long as aforementioned criteria is still met

What Can I Use The Funding For?

The grants must be used for COVID-19 related losses or expenses incurred between March 1, 2020 and April 1, 2021

- Payroll, commercial rent or mortgage payments for NYSbased property (but not any prepayments)
- Local property or school taxes associated with a small business location in NYS
- Insurance costs
- Utility costs
- Costs of personal protection equipment (PPE) necessary to protect worker and consumer health and safety
- Heating, ventilation, and air conditioning (HVAC) costs
- Other machinery or equipment costs
- Supplies and materials necessary for compliance with COVID-19 health and safety protocols
- Other documented COVID-19 costs as approved by Empire State Development

^{*} Funds may not be used to re-pay or service federal relief loans or any NYS business assistance programs

Restaurant Return To Work Tax Credit

Small, independently owned restaurants

- Less than 100 employees in areas designated by NYS as Orange or Red Zone for 30 consecutive days
- \$5,000 credit per new employee up to \$50,000
- Must demonstrate COVID-19 related losses of at least 40% in gross receipts or FTE employees

NY Forward Loan Fund

Economic Recovery loan program for small businesses, nonprofits, and small landlords

- 50 or fewer FTE employees
- Small businesses can apply for a loan in the amount of the lesser of (a) \$100,000 or (b) up to 100% of average monthly revenues in any 3-month period from 2019 or first quarter of 2020.
- Available to small businesses and nonprofits that DID NOT receive a PPP of greater than \$500,000 or EIDL of greater than \$150,000.
- Landlord loans will be targeted to owners with residential buildings of 50 units or less
- The loans are not forgivable, paid back over a 5-year term with 3% interest
- Loans can be used for working capital, inventory, marketing, operating and emergency maintenance, property taxes, utilities, rent, supplies, etc.

Activities in Albany

Enhanced protections for qualifying small business under Parker Richardson Act

- o Protection from Termination through December 22, 2021
 - Requires self-attestation of "change in financial circumstances due to COVID-19"
- o **Enhanced Payment Plans -** \$0 down, no late payment charges or penalties.
 - Customers who enter a COVID payment agreement are exempt from late payment charges for the entire term of the agreement, which could extend for 12 months.
- To qualify, a business must self-certify (attest)*:
 - 1. 25 or fewer employees
 - 2. not a publicly held company or a subsidiary
 - 3. not seasonal or temporary customer
 - 4. not a high usage customer as defined in 16 NYCRR § 13.5(b)(1)
 - * Exception for entities the utility can show has the resources to pay.


Protection from Eviction and Foreclosure

 On Sept 1, 2021 – Gov Hochul signed into law new protections for commercial tenants facing eviction or foreclosure through January 15, 2022. Prohibits eviction, mortgage foreclosure, tax foreclosure and lien sales for qualifying businesses that are independently owned and operated, with 100 or fewer employees and that demonstrate a financial hardship due to COVID.

Stay Tuned – More Relief Possible

- NYPSC considering Niagara Mohawk COVID-19 Customer Assistance Program. \$50 million in relief largely in the form or arrears forgiveness, tied to managing arrears – entering a payment agreement and making payments
- Expect a decision as early as Fall 2021 likely tied to deployment of other federal/state aid

New and Pending Small Business Offerings

Small Business Technical Assistance Program

- Statewide program, launching September 17
- Grants to chambers and other organizations to help neighborhood businesses
- Projects will provide services that are responsive to local needs, e.g.
 - Help in accessing grants and loans
 - Compliance with federal/state/local regulations
 - Accounting, HR, Marketing, Business Planning
- Part of a much broader National Grid community investment initiative – stay tuned!

New and Pending Small Business Offerings

COVID-19 Arrears Forgiveness Program

- Upstate Only
- Currently pending before the NYPSC
- Would provide relief for customers who enter into and complete -- a deferred payment agreement
- If approved, proposed bill credits could total up to 50% of a customer's arrears
- Retroactive to March, 2020

New and Pending Small Business Offerings

Area Development Rate (ADR)

- Approved by NYPSC in recent rate case
- Downstate only both NYC and Long Island
- Reboot of an old existing program
- Offers discounted rates to small businesses investing in targeted local areas
 - Federal Opportunity Zones
 - NYS Brownfield Opportunity Areas
 - NYC Industrial Business Zones
- Must be a new or expanding business in order to qualify
- Provides 35% delivery discount for 5 years

Saratoga Physical Therapy

Saratoga Springs, New York

Annual Energy Savings = \$5,758



- After a free energy assessment, Saratoga Physical Therapy decided to install indoor and outdoor LEDs, including parking lot lighting.
- By upgrading their lighting infrastructure, Saratoga
 Physical Therapy not only saved money on their monthly energy bill, but they ultimately increased their building's value.

Small Business Services Eligibility

- To qualify customers must have an active National Grid electric account that meets the following criteria:
 - Pay the System Benefits Charge (SBC)
 - Have an average annual peak demand under 110 kW
 - Have an electric rate code of SC1, SC2 or SC2D
 - Cannot have received an incentive from NYSERDA for the same measure
 - *New construction projects are not eligible for Small Business program incentives



Small businesses can apply for a loan in the amount of the lesser of (a) \$100,000 or (b) up to 100% of average monthly revenues in any 3-month period from 2019 or first guarter of 2020.

Available to small businesses and nonprofits that DID NOT receive a PPP of greater than \$500,000 or EIDL of greater than \$150,000.
